### Complex Commercial Litigation

Some of her noteworthy representations include:

— Represented generic pharmaceutical manufacturer against branded pharmaceutical manufacturer in commercial contract dispute relating to infringement of a patent.

— Achieved a significant settlement on behalf of the former Chief Executive Officer of an Australian public company who brought an arbitration alleging misrepresentation against a U.S. financial institution in connection with the sale of securities in certain securitized loans.

## Government Enforcement & White Collar Defense
